Our chillers use magnetic bearings and variable-speed drive, which increases their reliability and significantly reduces their operating costs in comparison to oil-lubricated systems. Today, we are moving into an important stage of our global development. That's why we need a solid financial partner like the Fund and are very happy that they've chosen to back us," stated Roger Richmond-Smith, president and CEO of Smardt Chiller Group.
